Home-School Agreement

The school will:

- Provide an environment which has been risk assessed in response to the COVID-19 infection.
- Adhere to social distancing rules as set out by the government as much as reasonably can.
- Provide a curriculum that meets the needs of your child's well-being, mental health, and academic needs.
- Contact parent/carers if your child develops COVID-19 symptoms.
- Inform you if staff or children in your child's 'bubble' develop symptoms of COVID-19, as this means you will all need to self-isolate for 14 days, or until the test comes back negative.
- Continue our clear and consistent approach towards rewards and sanctions for children as set out in the Behaviour Policy, as well as the expectations outlined in this agreement.
- Communicate between home and school through notices, newsletters, text, emails and the school website.

To help my child at school, I (the parents/carer) know, and understand, that:

- If my child, or anyone in my household, shows COVID-19 symptoms, I will not send my child to school, we will self-isolate for 14 days as a family, I will have my child tested, and I will let the school know the result as soon as possible via telephone.
- If my child, or another child in their 'bubble', shows COVID-19 symptoms at school, I will collect my child immediately.
- On my commute, and when picking up and dropping off my child, I will adhere to the 2m social distancing rules.
- When dropping off and picking up my child, I will strictly stick to the school timings for my child and follow the one-way system.
- My child will not bring any items into school with them (including bags) or take any items home with them (excluding a water bottle, lunch box, sun cream, sunhat, and coat if required).
- So that I have the option of washing my child's clothing frequently, they will not wear school uniform and I will send them in appropriate clothing for the activities planned in the school day.
- I will remind my child about social distancing rules, but accept that they are difficult to follow and that my child may not always do this successfully.
- My child will use good respiratory and hand hygiene.

- I will not enter the school unless I have a pre-arranged appointment (this can be made via telephone or email, and the majority of appointments will be via telephone).
- I will support all staff in their efforts to create an 'as safe as possible' environment during this crisis.
- I will read all letters/messages/emails that are sent home.
- I will inform the school immediately of any changes to parents'/carer and emergency contact details.
- I agree to collect my child immediately if they are deliberately breaking social distancing measures.
- I agree that I will abide to social distancing guidelines and understand that if I do not, my child will not be allowed to attend school.
- To protect the children, staff and families of those in my child's 'bubble', we will not mix with other groups of children whilst current Government restrictions are in place (this includes the play area adjoining school).

I (the child) will do my best to:

- Follow the social distancing rules, as explained by my teacher, both in the classroom and outside.
- Tell an adult if I feel unwell.
- Not bring things into school from home, unless it is my water bottle, lunchbox, sun cream, sun hat and coat (when I need them). I won't take thing from school home with me.
- Not mix with any other 'bubbles'.
- Only enter and exit the school building from my 'bubble's' door.
- Cough and sneeze in my elbow or a tissue and put the tissue in the bin.
- Wash my hands regularly, using soap and water.
- Behave well at all times to help myself and others to be safe.
- Follow online safety rules at home and at school.
- Understand that if I deliberately break the school rules, I will be sent home and may not be able to come back to school.
